- ◆ 1 mark for accurate economic terminology
- ◆ 1 mark for accurate economic terminology throughout
- ♦ 2 marks for integrating graphs as the candidate gave suitable graphs linked to the surrounding context

Presentation and Referencing

The candidate was awarded **3 marks** (out of 3) for:

- ◆ 1 mark for contents page, page numbering and appropriate headings
- 1 mark for referencing and footnoting
- ◆ 1 mark for bibliography

The candidate achieved a total of **36 marks** out of 40.
