

Commentary on candidate evidence

The candidate evidence has achieved the following marks for each question of this course assessment component.

Candidate 2

Section 1 – Human Development and Behaviour

Question 1(a)

The candidate was awarded **2 marks** for this question.

One mark for each phase:

- ◆ “During this phase some may isolate themselves from society.”
- ◆ “...may get back to their normal routine...”

Question 1(b)

The candidate was awarded **0 marks** for this question.

No marks awarded as no determinants of grief discussed.

Question 2

The candidate was awarded **0 marks** for this question.

No core conditions discussed.

Section 2 – Social Influences

Question 3

The candidate was awarded **4 marks** for this question.

- ◆ 2 marks awarded for first key feature as the feature has been correctly described, not just named.
- ◆ 2 marks awarded for second key feature as the feature has been correctly described, not just named.

Candidate has provided examples for each of the features.

Question 4

The candidate was awarded **2 marks** for this question.

One mark per sentence:

- ◆ “.....teachers and class mates may influence career choices..... be positive or negative.”

- ◆ “There is also the ‘hidden curriculum’.....manners, norms and social/communication skills.”

Question 5

The candidate was awarded **4 marks** for this question.

One mark per sentence for first feature:

- ◆ “...have ‘roles’ within society...”
- ◆ “..that is her role in society.”

One mark per sentence for second feature:

- ◆ “idea of self concept... not view herself... self concept may have decreased.”
- ◆ “....as she did and be worried to be seen as ‘different’!... a negative influence...”

Section 3 – Values and Principles

Question 6(a)

The candidate was awarded **3 marks** for this question.

One mark per sentence for the two stages:

- ◆ “When assessing...whole person.”
- ◆ “They may look...this be maintained.”
- ◆ “...continuous documents open to flexibility....needs and preferences.”

Question 6(b)

The candidate was awarded **3 marks** for this question.

One mark per sentence:

- ◆ “... a holistic, whole person approach.”
- ◆ “... as staff need training in order...”
- ◆ “... they are shared and communicated... everybody is aware...”

Question 7

The candidate was awarded **3 marks** for this question.

One mark per sentence for the Health and Social Care Standards feature:

- ◆ “.....decision making.....empowered.”

One mark per sentence for the Personalisation feature:

- ◆ “... helps to prevent institutionalization...”
- ◆ “... learn names... getting to know me forms are effective.”

Question 8

The candidate was awarded **4 marks** for this question.

One mark per sentence for compassion/empathy feature:

- ◆ "...show empathy, but not sympathy."
- ◆ "...show that we have an understanding...they are feeling..."

One mark per sentence for communication:

- ◆ "...with diverse groups of people..."
- ◆ "...we make adaptations for those struggling with communication..."

Overall, the candidate was awarded **25/40 marks**.
